The Other Side of the Veterans History Project

While attending the 2016 NCRA Legislative Boot Camp, I decided to make the most of my downtime between meetings on Capitol Hill, so I visited the Library of Congress Veterans History Project Center. I wanted to see where the veterans' stories I had transcribed in the past were kept and who uses them and for what purpose. My goal was to be able to take that information back to association, the Michigan Association of Professional Court Reporters, to garner support for this year's Veterans History Project (VHP). I started my mission at the Library of Congress Jefferson Building, only to discover that the Veterans History Project Center is located in the American Folklife Center over in the Madison Building. I was directed down staircases and underground tunnels to make my way there. I finally made it to my destination where I met Christy Chason, VHP representative. Christy greeted me with a smile and asked what she could do for me. I explained why I was in Washington, D.C., and I was hoping to be able to see the transcripts that I had sent in. Christy lit up, telling me how they love NCRF and the court reporters who have worked so hard transcribing the oral histories and what an important a role we play in the process. She apologized, saying that the transcripts are kept at an off-site location and that I wouldn't be able to see them on that day, but that I was welcome to stay and take a look around.

The first picture I came across was that of Rep. Ron Kind (WI). Christy explained to me that Rep. Kind authored the original Veterans' Oral History Project legislation after attending a family function with his father and uncle, both of whom served in the U.S. military, and wanting to document their experiences for future generations. He got a video camera and began recording their stories. I also found out that Rep. Kind's wife is a court reporter. The most interesting artifact I came across was a letter written home from a soldier to his beloved that was on government-issued tissue toilet paper. The original is in preservation environment, but there is an exact replica on the wall, along with a transcription next to it for easy reading. We proceeded on, looking at all the different photos and letters, and Christy shared the stories that went along with each of them. I was told that the transcripts we prepare are very important, as researchers, scholars, students, members of Congress, authors, and filmmakers access them on a daily basis. She was so happy that I had come to visit that she gave me a Veterans History Project pin that I proudly wore the rest of the day on my sweater to all of my meetings. I am currently awaiting a package of VHP swag from Christy to distribute at our next VHP Day coming up in November. I would encourage all of my colleagues to transcribe at least one pre-recorded veteran interview from NCRF or to participate in your local VHP Day this year. The experience is so incredibly rewarding, and it means so much to our veterans to have their experiences shared.

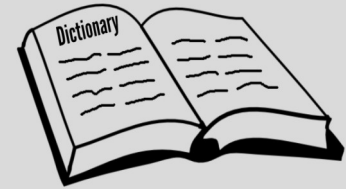

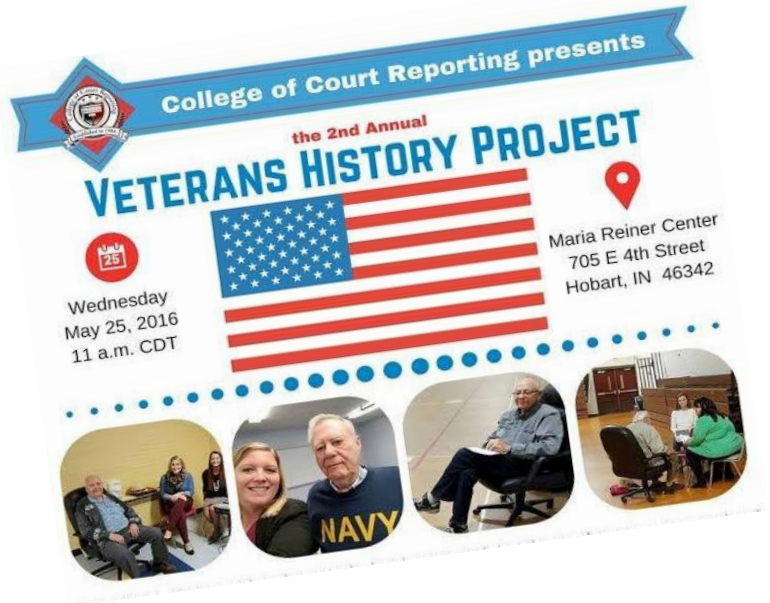

In honor of Memorial Day, CCR participated in another Veterans History Project!

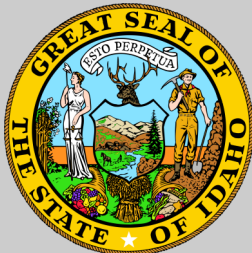

Court Reporting Changes Lives



On May 4, 2016, CCR hosted a Meet the Court Reporting Community online event. We had the opportunity to hear from Anthony Frisolone. He is an Official Court Reporter in the U.S. District Court for the Eastern District of New York. He is a Certified Realtime Reporter and also certified by NCRA as a Realtime Systems Administrator. He is also a Stenograph Certified Independent Training Agent offering training and education on Stenograph's Case CATalyst software. He regularly presents seminars to reporting firms and court reporting associations as well as conducts one-on-one training for court reporters who desire a more personalized educational experience. We wanted to share his amazing story with you.

“Reporting changed my life. I mean, I was a 20-year-old kid living in the Bronx, New York, working class family. I was the first to graduate college. The school I graduated from offered an associate’s degree. I was the first among my friends to have a solid full-time job. I bought a new car a year or two later after paying off my student loans, which, yeah, paid in two years. I mean, that’s the kind of money you can potentially bring in as a new reporter. Granted, I was staying at home with my family. But fast forwarding into my adult life, being married and having two kids. I have a beautiful house, and I’m able to put my kids through private school, and there’s not a worry about food on the table or the bills getting paid. I mean, the basics of life you don’t have to sweat. I think that’s how it’s changed my life. In 22 years, I’ve seen friends of mine get laid off for months or years at a time from the jobs in their chosen professions. Knock on wood. I’ve never had to worry about that. I’ve always had a steady job, had steady employment, even working for the government and going through the sequestration situation of a couple years ago. We didn’t have to worry because the chief clerk in our courthouse -- he did everything he could to keep us working. So hopefully it stays that way. I’ve met interesting people. I’ve met celebrities. I’ve met brilliant, brilliant people that I’ve learned so much from, and I’ve heard interesting things and have been places I never thought I would be -- inside buildings and things that most normal people don’t get to see and hear things that blew my mind. Just recently, you walk away from situations like that, and you’re like, ‘Wow. I can’t believe this is going on.’ It is. That’s how it’s changed my life. I came into this job as a kid. It taught me to grow up and have responsibilities and probably grow up faster than most 20-year-old guys have to grow up, but I’m glad for it.”
