The following are required for voice courses:

• Version 16.0 of Dragon Professional ("Standard" edition).

IMPORTANT: Purchase the <u>Dragon Professional</u> "standard" software (not "anywhere," "student," "academic," "legal," "medical," "law enforcement," or other named editions).


IMPORTANT: Download and install Case CATalyst <u>version 21.69</u> (with IVT).

Do NOT download and install version 22.


