New Students: Students interested in enrolling and in need of academic adjustment or auxiliary aids are urged to notify the Director of Admissions in writing by completing the "Disability Disclosure and Accommodation Form" which documents the nature and extent of the disability, type of accommodation or auxiliary aids needed, the class for which accommodations are requested and the start date of the accommodations. The request should be made at least four weeks in advance of the date needed. The Director of Admissions will respond within two weeks of receiving the request.

Enrolled Students: Currently enrolled students in need of assistance should contact the Executive Director in writing by completing the "Disability Disclosure and Accommodation Form" (defined above). The request should be made at least four weeks in advance of the date needed. The Executive Director will respond within two weeks of receiving the request.
